## Coverage

Components as described below are covered by years, hours, or 100% wear, whichever comes first. (See table pg.2)

- Leaks and/or breakage of new link assemblies, rollers, and idlers.
- Breakage of track shoes, sprockets, and segments.
- Leaks of welded idlers.
- Leaks of reshelled idlers and rollers.
- Replacement of bushings that exceed Caterpillar reuse guidelines for engrooving at bushing turn time.

Track Skidders and Track Feller Bunchers are not included.

When a component replacement is more economical, Caterpillar will cover the prorated cost of parts, based on the percentage of wear on the replaced component. Calculation of prorated amounts herein shall be made by Caterpillar in accordance with Caterpillar's policies and guidelines.

## Shoe Options

Caterpillar always recommends the narrowest shoe possible for adequate flotation. When misapplied, wide shoes can cause extraordinary structural damage to the link assembly.

## Customer Responsibilities

- Follow dealer recommended undercarriage management & inspection procedures.
- Maintain a functioning hour meter.
- Removal, installation, and transportation costs.
- Taxes, if applicable.
- Parts shipping charges in excess of the usual and customary.
- Deductible as required.
